- If an error is made in the payment of your Direct Debit, by PSL re Oldham Coliseum Theatre or your bank or building Society, you are entitled to a full and immediate refund of the amount paid from your bank or building society
 - If you receive a refund you are not entitled to, you must pay it back when PSL re Oldham Coliseum Theatre asks you to
